General Objective:

Deficits in the functioning of social dialogue in the transport sector, the protection of staff from third-party violence, as well as skills shortages and a lack of attractiveness of employment in the sector among women.

Specific Objective:

- 1** To transfer the best practices of social dialogue so far developed in the ATM sector to the other civil aviation subsectors, i.e. air crew and ground handling, and, simultaneously, trigger a country-based identification of the challenges and opportunities of improvement related to social dialogue applied to these sectors.
- 2** To facilitate a trans-national and EU-level exchange of experiences and practices between social partners of the civil aviation sector, with the aim to collect and elaborate recommendations for the European Sectorial Social Dialogue Committee dedicated to civil aviation.



Planned Activities and Work Packages:

The project is structured into four main Work Packages (WPs) to ensure a comprehensive approach:

- WP1: Project Management and Coordination
- WP2: Exchange of best practices and country-based survey to assess social dialogue of the whole civil aviation sector
- WP3: EU-level and international consultation within the civil aviation sector
- WP4: Communication, Awareness-raising, Exploitation
